使用方法

1. スマートフォンでQRコードを読み取り、Apple StoreまたはGoogle PlayからtracMo専用アプリをインストールしてください。



2. アプリ画面の手順に従ってtracMoをスマートフォンとペアリングしてください。
3. tracMoをあなたの大切なアイテムに取り付けてください。例えば、財布、鍵、自転車など。tracMoアプリからtracMoを鳴らしてアイテムを見つけることができます。また、tracMo本体のボタンを2回クリックしてスマートフォンを鳴らすことが可能です。

QUICK START GUIDE

1. Download the tracMo app from the App Store or Google Play by scanning the QR Code below:



2. Add tracMo by following the instructions on the tracMo app.
3. Attach tracMo to your items and find them at the click of a button on the tracMo app, or find your phone by double-clicking the tracMo tracker.

SAFETY INSTRUCTIONS

- To track your items, tracMo requires the app to be running in the background. Make sure the app is running at all times. When the app is not running, tracMo will send a notification to let you know.
- When replacing the battery, please replace with coin cell battery CR2032 ONLY.

WARRANTY SERVICE

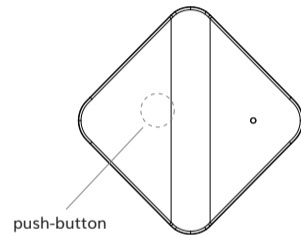

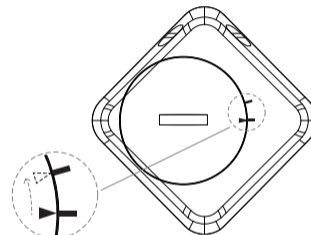
